*Section 938.357(4) does not provide a timeframe. However, 10 days is consistent with other change in placement procedures. In addition, see s. 938.51 which also requires notice of release within 15 days to the law enforcement agencies, school district, and county agency.

**When calculating the time periods listed above, 48 hours excludes Saturdays, Sundays, and "legal holidays"; 10 days excludes Saturdays, Sundays, and "holidays".

SHELTER CARE IS NOT A PLACEMENT!

- Pre Dispo CHIPS 30 days authorized, Court can extend by another 30 days, needs to be requested
- Post Dispo CHIPS 20 days between placements authorized
- Pre Adjudication JV 60 days authorized by the administrative code
- Post Adjudication JV 20 days between placements authorized
