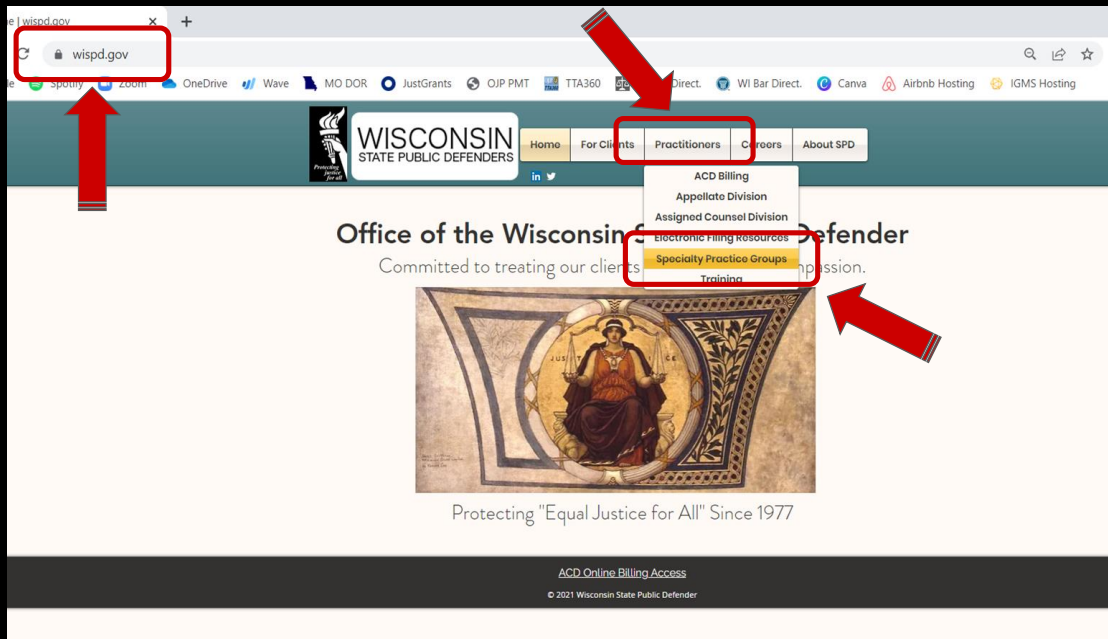

Specialty Practice Groups

Each practice group is led by a coordinator or coordinators who stays abreast of the latest developments in the practice area and shares this expertise as an advisor, mentor, and educator. Coordinators serve as a clearinghouse of sorts as they assist others in quickly changing areas of legal practice. Staff contact them as needed when they are preparing a client's case or have a question in a new or undeveloped area of the law. The coordinators also assist private bar (PB) attorneys with their questions related to the respective practice area.

Each coordinator pulls together practice materials, including motions, briefs, transcripts, case outlines, and research/articles/studies to share with practitioners. Coordinators keep track of the legal nuances and mundane details in their practice areas and catalog them for easy dissemination to attorneys when requested. They assist with the agency's training efforts, including presenting at the annual conference. Some coordinators conduct or assist with expert examinations at motion hearings and trials.



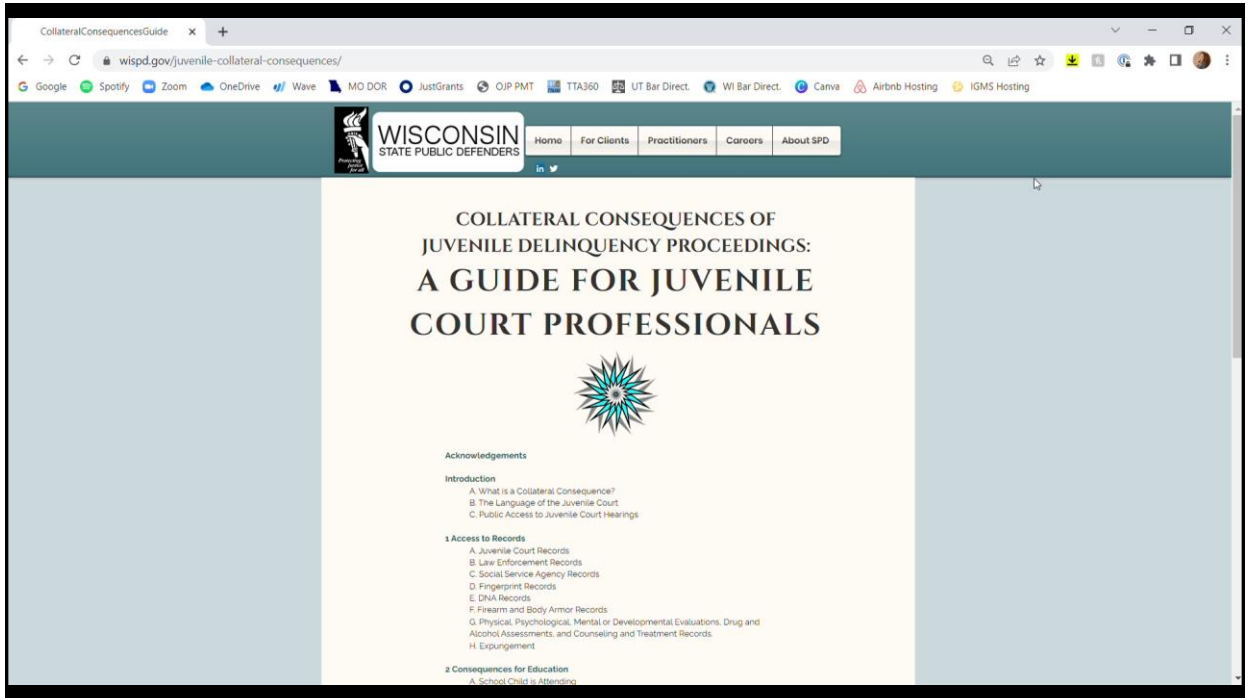

Records





Law Enforcement Records

- Share freely with Social Services, School Districts and other Law Enforcement
- Fingerprints to DOJ
- DNA sample to DOJ
- "On request" exceptions

Centralized Criminal History

- Law Enforcement TIME system
- Firearms checks
- Background checks
 - Licensing Agencies
 - Employers
 - Landlords
 - General Public

- School has notice
- DOJ has fingerprint data





Court Records

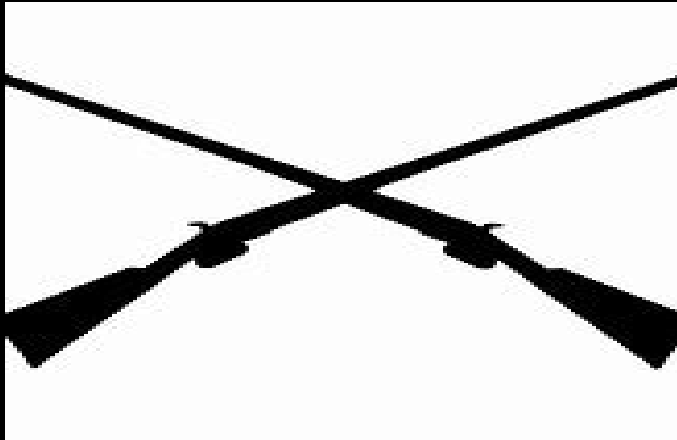
- **Exceptions to confidentiality**
- **Affirmative requirement to notify**
- **On request**
- **Evaluation records**

Expungement



Expungement of Court Record

- Age 17+
- Satisfactorily complied with dispositional order
- Standard: Youth will benefit, society won't be harmed
- Consider including as part of the dispositional order
- Court form



Expungement of Firearm Restrictions

- **Standard: Not likely to act in a manner dangerous to public safety**
- **Consider including as part of dispositional order**
- **Juvenile court form**



Expungement of DNA

- **No petition was filed alleging a violent crime within one year**
- **Petition was dismissed**
- **Was not adjudged delinquent of a violent crime**
- **Violent crime adjudication was reversed, set aside or vacated**
- **DOJ Form**



Expungement of Fingerprint Records

- **If taken at “arrest” and no charges filed**
- **Charges not prosecuted or dismissed**
 - **Requires non-prosecution/dismissal of all charges**
 - **Prosecution of lesser included offenses is insufficient**
- **Acquitted**
- **DOJ Form**

- **Court record**
- **Firearm registry**
- **Fingerprint Records**



School Child is Attending

- Notice from court clerk upon felony charge
- Notice from clerk adjudication/non-adjudication
- Grounds for suspension or expulsion
- Justice professionals contact with school
- Dispositional order



WIAA

- Every school district required to have Code of Conduct
- Specific game suspension requirements for drugs/alcohol/tobacco
- Law Enforcement records can be the sole basis for taking action
- Student charged/convicted of a felony?
- Self reporting?



Post Secondary Education

- **University of Wisconsin and technical college systems don't ask about criminal or delinquency backgrounds**
- **Common application**
- **Adjudication does not bar access to federal student financial aid**
- **Could affect screening for campus housing**

- **Assume school knows about the incident**
- **Can't control the decision to expel but can participate in the outcome**
- **If expelled will follow to other schools**
- **Could affect future sports involvement**
- **Resist assuming won't be college/tech school bound**





Licensing

- More than 200 professions require license
- Can't be denied based on delinquency adjudications unless exempt offense
- Application forms ask about convictions not adjudications
- Major exceptions are child welfare and child care



Employment

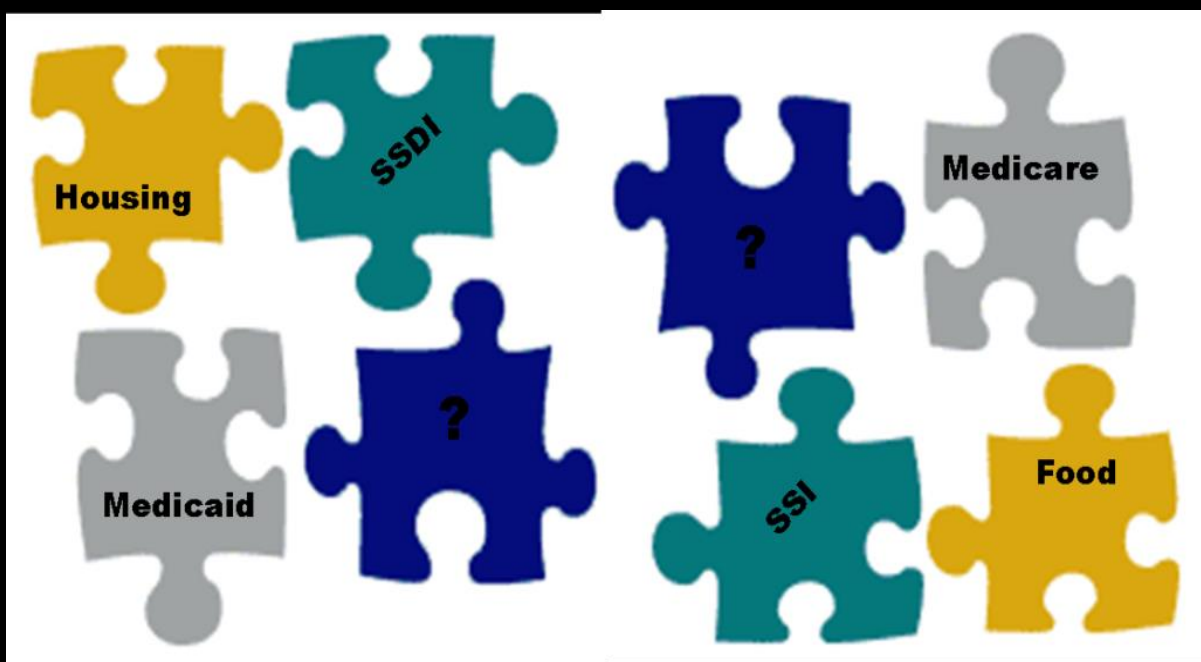
- **Illegal to discriminate on basis of conviction record, this includes adjudications**
- **Not discrimination if:**
 - **Conviction substantially related to circumstance of job**
 - **Education agencies: Felony conviction**
 - **Child welfare/child care: Serious offense convictions and adjudications**
- **Law enforcement certification**
- **Job Corps**



Military

- **Ineligible: Sex offender registry**
- **Ineligible: “Significant criminal record”, but waiver is possible**
- **“Criminal” is any adverse adjudication**
- **History of drug/alcohol use raises a medical question**

- Any felony drug adjudication precludes child care license or employment
- “Conviction” does not include “adjudication” on employment applications
- Single felony adjudication makes her ineligible for military, but waivable
- Job Corps



Housing

- Can terminate a private lease for criminal or drug related activity
- LPHA determine criteria for eviction and ineligibility
- Emphasis is on drug activity or sex offender
- Need not be a formal conviction/adjudication
- Confidentiality and on grounds v. off grounds activity

Other Public Benefits

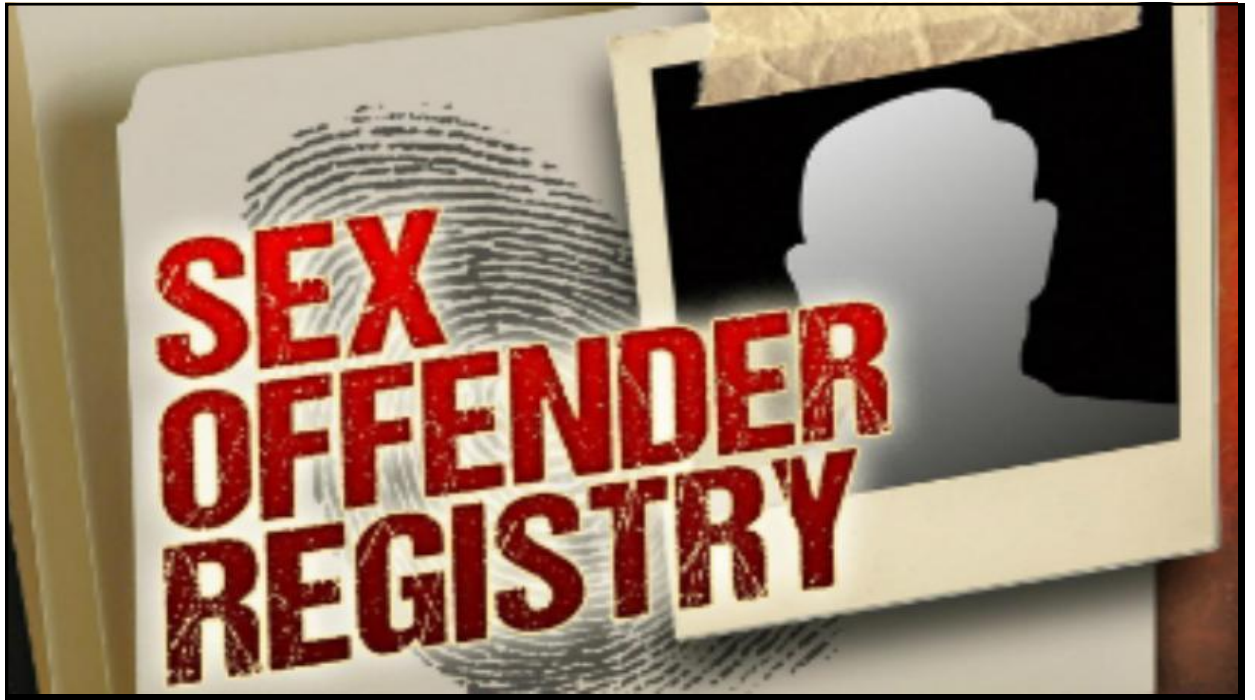
- Badgercare: Follows child placement
- SSI/SS: Follows child placement, but if in public institution with 16+ people benefits are suspended
- TANF/Wisconsin Works: If out of home longer than 3 months must notify program
- SNAP/Food share: Based upon family size

- Evidence of drug offense may be grounds for eviction
- Check LPHA rules and lease for requirements to notify public housing of adjudication
- Could affect future eligibility for public housing but rehabilitation could be shown; AODA counseling part of rehabilitation
- Confidentiality may prevent consequences off premise
- Benefits unaffected unless placed outside of home

Sex Offender Registration

- Discretionary in some cases
- “Romeo and Juliet” x2
- Stay of Registration



Sex Offender Registration

Onerous because:

- 15 or more years
- Required to notify registry when move, change schools, work, volunteer activities, set up email account, travel out of state
- Residency restrictions
- School grounds restrictions
- Police authorized to notify community organizations, even the public
- Moving out of state subjects to other state registration laws
- Ineligible for many jobs and the military
- DOC can impose additional rules



Best to consult with an immigration attorney!

Immigration

- **Juvenile delinquency findings are not convictions for immigration purposes but waiver to adult court as a juvenile could create a conviction**
- **Distinction between inadmissible and removal**
- **Drug trafficking makes you inadmissible**
- **Inadmissible or removal due to “bad conduct”**
- **Gang, sex offenses and violent offenses are a top priority**
- **Many decisions are discretionary**
- **Seeking expungement of juvenile record and fingerprint data may factor into discretionary decision**
- **Special Immigrant Juvenile status**

Immigration

- Determine status
- Consider prior arrest/delinquency record
- Current charges

*And then consult with an immigration attorney

- Would not face removal
- Could be denied admission if ever leaves US and wants to reenter
- Could negatively impact discretionary decision on naturalization
- Expungement may be useful

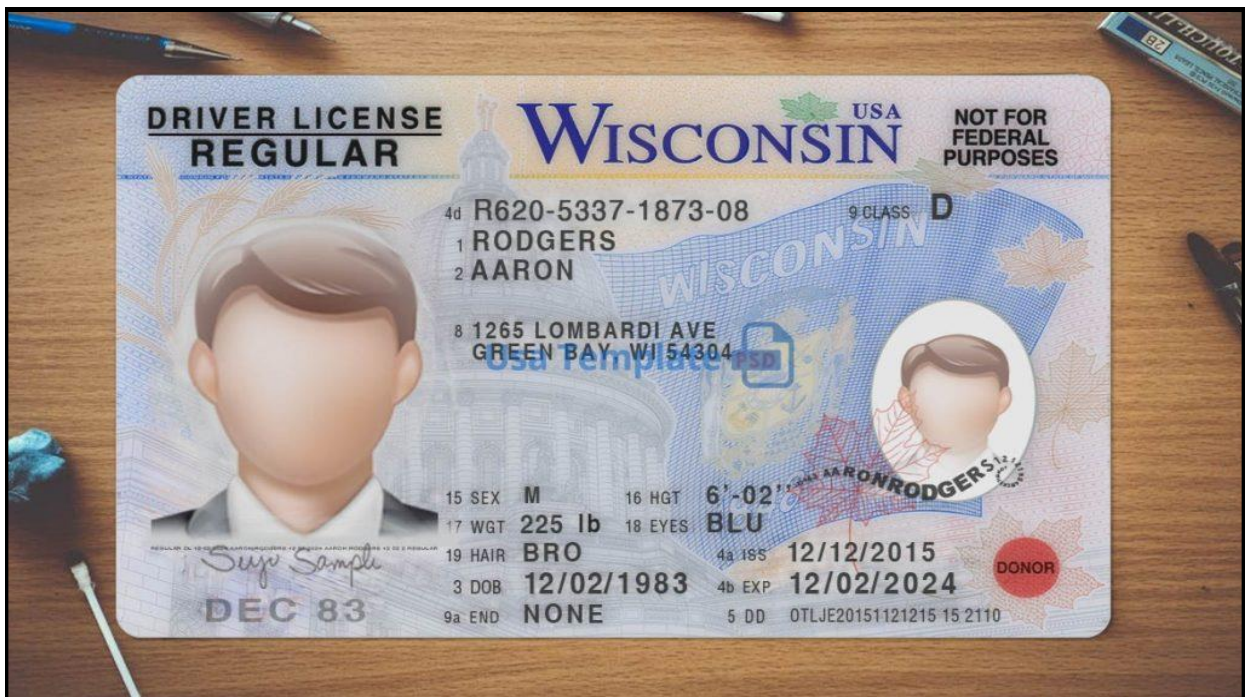

Other courts

- **Criminal court**
 - Considered in setting bail and PSI
 - As a basis for subsequent criminal charges
- **Admissible in family court**
- **Admissible in TPR court**
- **Can be used in ANY court for impeachment**
- **Civil court for damages**
- **Chapter 980 commitment**



Driver License

- **Can be suspended:**
 - **As a dispositional option**
 - **For failure to pay forfeiture or V/W surcharge**
 - **Sanction for violation of dispositional order**
- **Length of time of suspension varies from 6 months to 5 years**
- **Reinstatement may be burdensome and costly**



Hunting and Fishing License

- **Can be suspended:**
 - **Dispositional option**
 - **Failure to pay forfeiture or V/W surcharge**
 - **Sanction for violating a dispositional order**
- **Length of suspension from 30 days to 5 years**



Financial Impacts on Youth and Families

- Cost of legal counsel
- Cost of pre-trial custody and services
- Cost of psychological evaluations and drug and alcohol abuse assessments
- Testing for STI/HIV and communicable diseases
- Restitution, forfeitures, V/W surcharge,
- Cost of dispositional services

- **Foster Care**
- **Adoption**
- **Subsidized Guardianship**
- **Kinship Care**

- **Voting**
- **Jury Service**

Consequences to Marisol

- Education
- DOJ has fingerprint data
- Court Record
- Firearm Registry
- Preclusion from child care license/employment for 5 yrs
- Possible bar to Air Force
- Possible eviction from housing
- Possible effect on naturalization/admission
- Possible suspend driver, hunting, fishing license
- Financial costs to family
